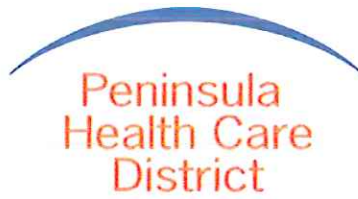

Dear Neighbors:

There is a lot going on in our neighborhood and we would like to tell you more about our part of it.

We are the Peninsula Health Care District and we have just moved up the street to our new offices at 1819 Trousdale Drive. We are working on two nearby projects:

•The "Marco Polo Project" is a health-focused senior neighborhood that will include health care facilities, housing, and professional offices on the land between Mills-Peninsula Hospital and Marco Polo Drive. We are now creating a master plan and design guidelines for it. We would like you to see what we have done so far and give us your feedback.

•The "Trousdale" is an assisted living and memory care facility at 1600 Trousdale that will be opening in the Fall of next year. It has already been approved and will break ground soon. We know that the neighborhood has been inconvenienced in the past by other projects and we would like to hear from you about what we can do to minimize disruptions on this project.
