THE POSITION

The PHCD Fitness Director will be accountable for developing, implementing and monitoring the safe and efficient operations and programs of the PHCD Health & Fitness Center at 1875 Trousdale (Center). The Director will serve as primary point of contact for all program members, instructors and vendors, and will coordinate with PHCD's Business Manager on all facility, IT and website issues and report to the Chief Executive Officer.

JOB DUTIES

- Develop, implement and ensure compliance to policies and procedures consistent with the County Department of Health and CDC guidelines to ensure member and staff safety.
- Attract and retain members.
- Recruit, hire, train and supervise Center staff, instructors, coaches, and independent contractors.
- Create and maintain monthly staffing schedule, filling the gaps when needed.
- In collaboration with CFO, develop, implement and monitor annual Center budget.
- Create monthly class schedule and descriptions.
- Teach specialty and evidence-based classes.
- Consult on development of marketing, social media and website content.



- ' Monitor and promptly initiate corrective actions to address environmental and equipment repair needs.
- Participate in PHCD Board, Committee and team meetings as requested.
- ' Identify and participate in community activities to promote the Center and its health benefits for PHCD constituents.
- Work in accordance with established safety guidelines with emphasis on the use of proper body mechanics, proper use of PPE and overall safe work practices.
- Management of Optum and American Specialty Health insurance programs.
- Organize educational speakers for members on a regular basis and provide educational resources to members on various topics in resource library.
- Maintain Automated External Defibrillator monthly.
- Research and lead efforts to become a Medical Certified Facility.

CUSTOMER SERVICE

- Conduct periodic member satisfaction surveys to solicit feedback to inform expansion, revision and/or improvements of Center programs.
- Respond promptly to member requests.
- Ensure member concerns are appropriately resolved and Supervisor is notified as warranted.
- Maintains a professional image to the public and Center members.
- Accessibility to staff during operating hours in the event of any emergencies, questions, etc.

INTERPERSONAL RELATIONSHIPS

- ' Consistently model a service attitude towards others, take ownership in solving problems and take the initiative to improve situations.
- Work as a team player within the Center and with PHCD colleagues.
- Ensure timely, meaningful communications with Center members and PHCD teammates.

 PHCD teammates, business associates and public members.

- Ability to operate fitness equipment, Mindbody membership system and basic office equipment and software such as PC, copier, Microsoft Word, Outlook, etc.
- Ability to be flexible and willing to take on other duties that may arise and are consisted with the qualifications and aptitude for this position.

- 4-year college degree in exercise science or fitness-related field highly preferred. May accept experience in related field in lieu of degree.
- CPR/First Aid & National Group Fitness Certification preferred (ACE, IDEA, etc.)
- ' Must be eager to learn and continue professional development and education
- ' Strong communication skills.
- ' Understand principles of physical fitness and proper exercise techniques.

PREFERRED QUALIFICATIONS

- ' 2 years of management experience in the fitness arena.
- 5 years of experience working directly with older adults.
- Well-versed in basic anatomy, kinesiology, exercise modification for all populations and ACSM Guidelines for frequency, intensity, duration and mode.
