

Peninsula Health Care District Funds Over \$1 Million to Support Vital Community Services and Resources in 2024

Burlingame, CA (December 20, 2023) - On December 14, 2023, the Peninsula Health Care District (PHCD) Board of Directors voted to fund over \$1 million to diverse service providers for the 2024 grant cycle. Thirty-three organizations will receive two-year and one-year grants.

Through the Community Grants Program (CGP), Peninsula Health Care District partners with community-based organizations to address residents' health and mental health needs. Grantees share PHCD's vision of supporting residents in achieving optimal health and wellness through education, prevention, and access to essential services.

"We are proud to partner with these important organizations committed to improving our community's health and well-being," said Ana M. Pulido, CEO of Peninsula Health Care District. "Through our Community Grants Program, we are working with trusted providers who are dedicated to making a significant and positive impact on the lives of District residents."

"After a thorough review of applicants, we are proud to honor 33 organizations for their critical impact on the community," said Rick Navarro, MD, Board member of Peninsula Health Care District and Chair of the Community Health Investment (CHI) Committee. "Each organization provides an essential community health service and is integral to fulfilling our District's mission."

For the 2024 grant cycle, four focus areas were identified:

- 1. Healthy Aging Promoting socialization and connectivity.
- 2. Mental Health Including prevention services and programs.
- 3. Preventive Health Advancing education, nutrition, screenings, and physical activity.
- 4. Health Equity Directed at increasing health care access.
